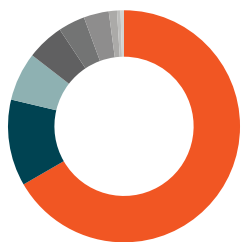

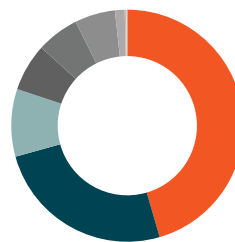

Solactive E-commerce Index The Solactive E-commerce Index tracks the price movements in shares of companies which are (or are expected to be in the near future) active in the field of E-commerce.
