DEFINITIONS

Solactive Global Gold Explorers & Developers Total Return Index	The Solactive Global Gold Explorers Total Return Index tracks the price movements in shares of companies which are active in the gold mining industry as an explorer. This implies that a decision about production from the respective gold mining projects in which the companies are involved in has not been made yet.
MSCI ACWI Index	MSCI ACWI Index captures large and mid cap representation across 23 Developed Markets (DM) and 24 Emerging Markets (EM) countries. The index covers approximately 85% of the global investable equity opportunity set. DM countries include: Australia, Austria, Belgium, Canada, Denmark, Finland, France, Germany, Hong Kong, Ireland, Israel, Italy, Japan, Netherlands, New Zealand, Norway, Portugal, Singapore, Spain, Sweden, Switzerland, the UK and the US. Sharpe Ratio	Measures the return for each unit of risk. The risk free rate is subtracted from the mean return and is divided by the standard deviation of returns.
